Stop leak if safe to do so. Wipe up small spills with paper towel and dispose of in bin. Absorb large spills with sand, earth, vermiculite or some other absorbent material. Collect the spilled material and place into a suitable container for disposal.

7 Handling and Storage

Precautions for Safe Handling:

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of vapours/mists. Food, beverages and tobacco products should not be stored or consumed where this material is in use. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use. Provide eyewash fountains and safety showers in close proximity to points of potential exposure.

Conditions for Safe Storage:

Store in a cool, dry and well ventilated area. Keep in original container tightly closed when not in use. Protect from direct sunlight. Store at approximately 25 C. Product to be handled only by qualified staff in dental laboratories.
